VOTES AND PROCEEDINGS

OF THE

HOUSE OF REPRESENTATIVES.

FRIDAY, 29TH NOVEMBER, 1912.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Paper.—Mr. Roberts presented, pursuant to Statute—
 - Defence Act—Regulations Amended (Provisional)—Military Forces—Financial and Allowance—Statutory Rules 1912, No. 224.
- 3. Constitution Alteration (Trade and Commerce) Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed.
 - Mr. W. Elliot Johnson moved, That the debate be now adjourned.
 - Question—That the debate be now adjourned—put and passed.
 - Ordered—That the resumption of the debate be made an Order of the Day for the next day of meeting.
- 4. Postponement of Orders of the Day.—Ordered—That the remaining Orders of the Day, Government Business, be postponed until after Notice of Motion No. 1.
- Immigration Bill (1912.)—Mr. Thomas moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Immigration Restriction Act* 1901-1910.
 Question—put and passed.
 - Mr. Thomas then brought up the Bill accordingly, and moved, That it be now read a first time.
 - Question—put and passed.—Bill read a first time.
 - Ordered—That the second reading be made an Order of the Day for the next day of meeting.
- 6. Special Adjournment.—Mr. Hughes moved, That the House, at its rising, adjourn until Monday next at three o'clock p.m.

 Question—put and passed.
- 7. ADJOURNMENT.—Mr. Hughes moved, That the House do now adjourn.

 Debate ensued.

Question-put and passed.

- And then the House, at nine minutes past four o'clock p.m., adjourned until Monday next at three o'clock p.m.
