1 The House met, at 9.30 a.m., pursuant to adjournment. The Speaker (the Honourable Neil Andrew) took the Chair, and read Prayers.

2 AGRICULTURE, FISHERIES AND FORESTRY LEGISLATION AMENDMENT BILL (NO. 1) 2002

Mr Truss (Minister for Agriculture, Fisheries and Forestry), pursuant to notice, presented a Bill for an Act to amend the law relating to agriculture, fisheries and forestry, and for related purposes.

Bill read a first time.

Mr Truss moved—That the Bill be now read a second time.

Mr Truss presented an explanatory memorandum to the Bill.

Debate adjourned (Dr Lawrence), and the resumption of the debate made an order of the day for the next sitting.

3 TARIFF PROPOSALS

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration) moved—

Customs Tariff Proposals No. 1 (2002).

Debate adjourned (Dr Lawrence), and the resumption of the debate made an order of the day for the next sitting.

4 AUSTRALIAN PROTECTIVE SERVICE AMENDMENT BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Williams (Attorney-General), the Bill was read a third time.

5 DIESEL FUEL REBATE SCHEME AMENDMENT BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Emerson who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the bill a second reading, the House condemns the Government for:

- (1) failing to deliver on their commitment to develop an Energy Grants (Credits) Scheme to replace both the Diesel and Alternative Fuel Grants Scheme and the Diesel Fuel Rebate Scheme;
- (2) failing to prioritise support for the accelerated uptake of renewable electricity generation as a viable alternative to diesel rather than extend the diesel rebate that would lead to long term greenhouse gas reductions; and

(3) conducting the Fuel Taxation Inquiry only for cynical and expensive election purposes with no intention of a genuine review of fuel taxation issues".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General

Leave granted for third reading to be moved forthwith.
