13 INTERNATIONAL CRIMINAL COURT BILL 2002

Mr Williams (Attorney-General), pursuant to notice, presented a Bill for an Act to facilitate compliance by Australia with obligations under the Rome Statute of the International Criminal Court, and for related purposes.

Bill read a first time.

Mr Williams moved—That the Bill be now read a second time.

Paper

Mr Williams presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Swan), and, by leave, after debate, the resumption of the debate made an order of the day for a later hour this day.

14 INTERNATIONAL CRIMINAL COURT (CONSEQUENTIAL AMENDMENTS) BILL 2002

Mr Williams (Attorney-General), pursuant to notice, presented a Bill for an Act to amend the *Criminal Code Act 1995* and certain other Acts in consequence of the enactment of the *International Criminal Court Act 2002*, and for other purposes.

Bill read a first time.

Mr Williams moved-That the Bill be now read a second time.

Paper

Mr Williams presented an explanatory memorandum to the Bill.

Debate adjourned (Mr Rudd), and, by leave, the resumption of the debate made an order of the day for a later hour this day.

15 WORKPLACE RELATIONS AMENDMENT (GENUINE BARGAINING) BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr McClelland, viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not denying the bill a second reading, the House condemns the Government for:

- (1) unreasonably emasculating the powers of the AIRC to resolve industrial disputes in the interests of the parties;
- (2) interfering with the AIRC's discretion to deal with industrial disputes in the most appropriate way; and
- (3) failing to put forward constructive proposals to enable the Commission to direct parties to bargain in good faith"—

Debate resumed.

Debate adjourned (Mr Entsch—Parliamentary Secretary to the Minister for Industry, Tourism and Resources), and the resumption of the debate made an order of the day for a later hour this day.

16 INTERNATIONAL CRIMINAL COURT BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Member ordered to withdraw

At 9.16 p.m. the Member for Indi (Ms Panopoulos) was ordered, under standing order 304A, to withdraw from the House for one hour for continuing to interject after a warning had been given from the Chair, and she accordingly withdrew from the Chamber.

Debate continued.

Question—That the Bill be now read a second time—put and passed—Mr Katter dissenting—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Williams (Attorney-General), the Bill was read a third time.

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Williams (Attorney-General), the Bill was read a third time.

18 ADJOURNMENT

It being approximately 10.30 p.m.—The question was proposed—That the House do now adjourn. Debate ensued.
