$8\,$ requirements for the declaration of members' interests

omit "\$200", substitute "\$300".

Paragraph (l) (sponsored travel)—omit the paragraph, substitute:

"(l) any sponsored travel or hospitality received where the value of the sponsored travel or hospitality exceeds \$300".

Mr McClelland moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not denying to give the Bill a second reading, the House calls on the Government to:

- (1) establish a complaints mechanism for the Australian Protective Service comparable to the *Complaints (Australian Federal Police) Act 1981*;
- (2) provide Australian Protective Service officers with appropriate training to exercise the powers under the proposed legislation;
- (3) upgrade security at regional airports; and
- (4) ensure that the risk management culture at privatised airports results in security services that are the best and not simply the cheapest".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.
