Mr Griffin (Minister for Veterans' Affairs), for Ms Macklin (Minister for Families, Housing, Community Services and Indigenous Affairs), pursuant to notice, presented a Bill for an Act to amend the law relating to family assistance, child support and veterans' affairs, and for related purposes.

Bill read a first time.

Mr Griffin moved—That the bill be now read a second time.

3 FINANCIAL TRANSACTION REPORTS AMENDMENT (TRANSITIONAL ARRANGEMENTS) BILL 2008

Mr Debus (Minister for Home Affairs), pursuant to notice, presented a Bill for an Act to amend the *Financial Transaction Reports Act 1988*, and for related purposes.

Mr Debus presented an explanatory memorandum to the bill.

Bill read a first time.

4 AUSTRALIAN ORGAN AND TISSUE DONATION AND TRANSPLANTATION AUTHORITY BILL 2008
