#### 9 MESSAGE FROM THE SENATE—HEALTH INSURANCE AMENDMENT (COMPLIANCE) BILL 2009

Message No. 360, 23 November 2009, from the Senate was reported returning the Health Insurance Amendment (Compliance) Bill 2009 with amendments.

Constitutional questions raised by proposed Senate amendments—Statement by Deputy Speaker.

The Deputy Speaker made the following statement: The Speaker's attention has been drawn to proposed Senate Amendments numbers (1) and (10). On behalf of the Speaker, I inform the House of the Constitutional questions raised by the amendments.

As I understand it, advice has been provided that the amendments, if enacted, would have the effect of increasing amounts that would be payable under a standing appropriation in the *Health Insurance Act* 1973, and would be construed as appropriating money.

There is doubt that the Senate may proceed in these circumstances by way of amendment because of section 53 of the Constitution. Among other things, this section prohibits the Senate from amending any bill so as to increase "any proposed charge or burden on the people". The view has been taken that where revenue or moneys are to be appropriated in these circumstances, section 56 of the Constitution requires that the proposed appropriation must be recommended by a message from the Governor-General.

The House will need to consider the way in which it should proceed to deal with the matters raised in the Senate amendments. If the House wishes to entertain the proposal reflected in the amendments, it may choose to proceed by alternative means.

Ordered—That the amendments be considered immediately.

On the motion of Ms Roxon (Minister for Health and Ageing), Senate amendments Nos 2 to 9 were agreed to, after debate.

Ms Roxon moved—That Senate amendments Nos 1 and 10 be disagreed to.

Ms Roxon presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendments Numbers 1 and 10

These amendments have no substantial relationship to the Health Insurance Amendment (Compliance) Bill 2009.

These amendments passed by the Senate would mean that in the event that an item in a table of medical services prescribed in accordance with subsection (1) is disallowed under section 42 of the *Legislative Instruments Act 2003*, the corresponding item, if any, in the previous regulations is taken to apply in place of the disallowed item from the time of disallowance.

The Government has a fiscal responsibility to manage the budget in a sustainable way that provides the best outcome for the taxpayer. This amendment could hinder the Government's ability to ensure sustainability of the medical benefits program in the face of population ageing and growth in the costs of medical technology, prevent the reinvestment of appropriate dividends from progress in medical technology and practice towards needed health reforms and otherwise undermine the Government's ability to deliver the best outcome for the taxpayer.

These amendments are also intended to act retrospectively from 26 October 2009. This is clearly intended to have an effect of increasing the Medicare Benefits Schedule (MBS) fee for items disallowed by the Senate on 28 October 2009. Legal advice to the Government confirms that this effectively would be increasing a standing appropriation and would be construed as appropriating money. Thus, these amendments must be considered to be unconstitutional as contrary to s.53 of the Constitution, which provides inter alia that:

- Proposed laws appropriating revenue or moneys or imposing taxation shall not originate in the Senate: and
- The Senate may not amend any proposed law so as to increase any proposed charge or burden on the people.

On this basis, the House of Representatives does not support these amendments.

On the motion of Ms Roxon, the reasons were adopted.
