1 The House met, at 2 p.m., pursuant to adjournment. The Speaker (Mr Jenkins) took the Chair, and read Prayers.

**2 RETURNS TO WRITS—HIGGINS AND BRADFIELD DIVISIONS**

The Speaker announced that he had received returns to the writs which he had issued on 30 October 2009 for the election of Members to serve for the electoral divisions of Higgins, in the State of Victoria, and Bradfield, in the State of New South Wales, to fill the vacancies caused by the resignations of Mr Costello and Dr Nelson, respectively. By the endorsement on the writs, it was certified that Kelly Megan O'Dwyer had been elected as the Member to serve for the division of Higgins and that Paul William Fletcher had been elected as the Member to serve for the division of Bradfield.

**3 OATHS OF ALLEGIANCE BY MEMBERS**

Kelly Megan O'Dwyer and Paul William Fletcher made and subscribed the oath of allegiance required by law.

**5 QUESTIONS**

Mr Abbott (Leader of the Opposition), by leave, moved—That this House calls on the Prime Minister to be upfront with the Australian people and small business about the impact of his great big new tax by:

- (1) accepting the challenge of the Leader of the Opposition to debate the so called “greatest moral challenge of our times”, namely the impact of climate change and the benefits of the Opposition’s policy of direct action on climate change rather than the Government’s great big new tax on everything as envisaged by its Emissions Trading Scheme; and
- (2) allowing the Prime Minister and Leader of the Opposition to be allocated 30 minutes each, a total of one hour, to have that debate immediately in the House of Representatives.

Mr Rudd (Prime Minister) moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “this House:

- (1) condemns the Leader of the Opposition for:
  - (a) being a weathervane on climate change policy;
  - (b) presenting today a climate change plan that is nothing more than a climate con job; and
  - (c) a con job which does less, costs more, and will mean higher taxes; and
- (2) reaffirms its commitment to take action to avoid dangerous climate change in the interests of this and future generations of Australians.”

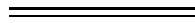

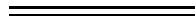
