28 PRIVILEGE—STATEMENT BY SPEAKER

The Speaker referred to the matter of privilege raised in the House earlier today by Mr Slipper relating to the taking of a photograph of the Member for Fisher in the House of Representatives.

The Speaker stated that acts which may obstruct or impede the House in performing its functions, including causing this indirectly by bringing the House into odium, contempt or ridicule or by lowering its authority, may constitute contempts. However, while the taking of an unauthorised photograph in the chamber could potentially be seen as a contempt, he would take action directly against a member for disorderly conduct should he become aware of such behaviour.

The Speaker referred to the only comparable example of which he was aware, where a member of the NSW Legislative Assembly had raised, as a matter of privilege, the taking of an unauthorised photograph in the chamber. On that occasion, after investigation, the Speaker in NSW had reported to the Assembly that a staff member in the Premier's Office had admitted to taking the photograph, had apologised unreservedly, and had destroyed the photograph. No further action had been taken.

The Speaker said that the Member for Fisher had referred to an interference with the free performance by him of his duties as a member, as a result of the photograph having been passed on to his local newspaper and having been published. The Speaker stated that he could understand that the publication of the photograph was embarrassing to the member and he could see how it might influence the views that his constituents might have of him. In the absence of more specific evidence of the effect that this has had on the free performance of his duties, however, and given the consistently held view that the House's privileges and contempt powers should be exercised sparingly, he did not find that a prima facie case had been established.

(4) any variation to this arrangement be made only by an action by the Speaker.
