# FRIDAY, 7TH NOVEMBER, 1913.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Assent to Appropriation (Works and Buildings) Bill 1913-14.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:-

Message No. 20.

A Bill intituled "An Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and fourteen for the purposes of Additions, New Works, Buildings, &c.," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

3. Want of Confidence in the Government.-Mr. Fisher moved, pursuant to notice, That the Government does not possess the confidence of this House.

And the bells being rung for a division-

Mr. Thomas apologized, and, by leave, the motion was withdrawn.

And certain Points of Order having been raised and decided, the Orders of the Day were called on.

4. GOVERNMENT PREFERENCE PROHIBITION BILL.—The Order of the Day having been read for the second reading—Mr. W. H. Irvine moved, That the Bill be now read a second time.

Mr. W. H. Irvine addressing the House, and not having concluded his speech, the House ordered that he have leave to continue his speech when the debate is resumed.

Ordered—That the debate be now adjourned.

Mr. W. H. Irvine moved, That the resumption of the debate be made an Order of the Day for Tuesday next.

Mr. Fisher moved, That the word "Tuesday" be omitted with a view to the insertion of the word "Wednesday" in place thereof.

Mr. Webster moved, That the question be now put.

Question—That the word ["Tuesday"] proposed to be omitted stand part of the question—put.
