### TUESDAY, 2ND DECEMBER, 1913.

1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

ROBERTS).—Mr. Joseph Cook, having announced with deep regret the sudden death in the Queen's Hall within the last few minutes of the honorable Member for Adelaide (the Honorable Ernest Alfred Roberts) moved, by leave, That this House places upon record its high appreciation of the great public services of the late Member for Adelaide, the Honorable E. A. Roberts, and tenders its sincere sympathy to the bereaved family of an eminent citizen whose untimely decease is a great loss to the Commonwealth.

And Mr. Fisher having seconded the motion, and all Members present having risen in silence-Question-passed.

Resolved — That Mr. Speaker be requested to transmit the foregoing Resolution and a copy of the addresses delivered thereon, to Mrs. Roberts. And then—
