MAY IT PLEASE YOUR EXCELLENCY-

We, the House of Representatives of the Parliament of the Commonwealth of Australia, in Parliament assembled, beg to express our loyalty to our Most Gracious Sovereign, and to thank Your Excellency for the Speech which you have been pleased to address to Parliament—

Mr. Fisher moved an amendment, That the following words be added to the proposed Address:—

"but regret to have to inform you that your Advisers deserve censure for having failed to safeguard the interests of the people of the Commonwealth."

Mr. Joseph Cook moved, That the debate be now adjourned.
