8. WAR PRECAUTIONS BILL.-Mr. Hughes moved, pursuant to notice, That he have leave to bring in a Bill for an Act to enable the Governor-General to make Regulations and Orders for the safety of the Commonwealth during the present state of war.

Mr. Hughes then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time. Mr. Fisher moved, by leave, That the Standing Orders be suspended, to enable the Bill to be passed through its remaining stages without delay.

Debate ensued.

Title agreed to. Bill to be reported without amendment.

Message No. 9. In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the

Commonwealth Bank Act 1911.

Ordered, by leave-That the foregoing Message be considered forthwith in Committee of the whole-House

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Resolved, on the motion of Mr. Fisher-That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Commonwealth Bank Act 1911. Resolution to be reported.

No. 2.—Pages 4 and 5, leave out clause 17.

No. 3.—Page 12, clause 47, line 17, leave out "five" insert "two". No. 4.—Page 21, clause 80, line 35, leave out "two" insert "seven". No. 5.—Page 21, clause 80, line 44, leave out "two" insert "seven".

No. 6.—Page 23, clause 82, line 5, leave out "one year" insert "seven years."
