## HOUSE OF REPRESENTATIVES.

TUESDAY, 15TH DECEMBER, 1914.

1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. WAR PENSIONS BILL.—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 23—  
Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

*(In the Committee.)*

*Resolved*, on the motion of Mr. Jensen—That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the grant of Pensions upon the death or incapacity of Members of the Defence Force of the Commonwealth and Members of the Imperial Reserve Forces resident in Australia, whose death or incapacity results from their employment in connexion with warlike operations.

Resolution to be reported.

The House resumed ; Mr. Chanter reported accordingly.

Ordered—That the Report be considered at once.

The said Resolution was read, and, on the motion of Mr. Jensen, was adopted by the House.

3. WAR PENSIONS BILL.—The Order of the Day having been read for the second reading—Mr. Jensen moved, That the Bill be now read a second time.  
Mr. Joseph Cook moved, That the debate be now adjourned.  
Question—That the debate be now adjourned—put and passed.  
Ordered—That the resumption of the debate be made an Order of the Day for a later hour this day.
4. LAND TAX ASSESSMENT BILL (1914).—The Order of the Day having been read for the second reading—Mr. Fisher moved, That the Bill be now read a second time.

On the motion of Mr. Hughes the following amendment was made, after debate :—

Lines 10 to 18, omit paragraphs (a) (b) and (c) and insert the words “by omitting all words after the words ‘perpetual lease’ and inserting in their stead the words ‘or a lease with a right of purchase or a lease of land to be used for pastoral grazing or cultivation purposes or a homestead lease or a mining lease) shall not be liable to assessment or taxation in respect of the estate, and the owner of a leasehold estate under any such laws for a term not greater than one year certain shall not be so liable :

Provided that in the assessment of the unimproved value of a lease the value of any metals or minerals or other rights reserved to the Crown shall be excluded.’”

Clause, as amended, debated.

Question—That the clause, as amended, stand part of the Bill—put.

Clause 3 agreed to.

New Clauses—

Mr. Greene moved, That the following new clause be added to the Bill :—

“2A. Sub-section (1.) of section forty-four of the *Land Tax Assessment Act 1910-1912* is hereby amended by inserting after the words ‘District Court of a State’ the words ‘or in cases where the assessment made by the Commissioner is less than Ten thousand pounds a Stipendiary or Police or Special Magistrate.’”

Debate ensued.

Proposed new clause, by leave, withdrawn.

Mr. Abbott moved, that the following new clause be added to the Bill :—

“4. Section 44 of the *Land Tax Assessment Act 1910-1912* is amended by adding to the end thereof the following sub-section —

‘(4.) The owner of pastoral or agricultural lands may notify the Commissioner within the time and manner provided for appeals, that he desires the appeal shall be heard by arbitration and thereupon the appeal shall be settled by arbitration in accordance with the laws relating to arbitration of the State in which the land is situated.’”

Debate ensued.

Question—put and negatived.

Title agreed to.

Bill to be reported with amendments.

The House resumed ; Mr. Chanter reported accordingly.

Mr. Hughes moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

On the motion of Mr. Hughes, the House adopted the Report.

Mr. Hughes moved, That the Bill be now read a third time.

(3.) The provisions of section five, sub-sections (2.) and (3.), and section six of the *Land Tax Assessment Act 1910-1912*, shall apply in relation to the office of Commissioner under this Act as they apply in relation to the Office of Commissioner of Land Tax.”

Clause, as amended, agreed to.

Clauses 6 to 9 omitted.

Clauses 10 to 12 agreed to.

Clause 13 debated—

Progress to be reported, and leave asked to sit again.
