7. PATENTS, TRADE MARKS AND DESIGNS BILL (1915) .- The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question-put and passed.-Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 and 2 agreed to. Clause 3-

On the motion of Mr. Hughes, after debate, the following amendments were made :----After "sub-clause (1.)" insert new sub-clauses-

"(1A.) It shall be a defence to a prosecution under this section if the defendant satisfies the Court that a petition for the revocation of the patent, or for the removal of the trade mark or design from the register, as the case may be, would be successful."

(1B.) No prosecution under this section shall be brought except by the Attorney-General or a person authorized in that behalf by the Attorney-General."

Clause, as amended, debated, and agreed to.

Title agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Chanter reported accordingly.

Ordered-That the consideration of the Report be made an Order of the Day for to-morrow.
