- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION. Mr. Orchard rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The administration of the Military Camp at Liverpool." Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in

their places, and more than the necessary number of Members having risen accordingly-

Mr. Orchard moved, That the House do now adjourn, and not having, in compliance with Standing Order No. 39, concluded his speech within half an hour, the honorable Member was, by leave of the House, allowed to continue his speech.
