In assessing the rate of pension due to a dependant the Commissioner or Deputy-Commissioner shall assess it at a rate not less than the amount contributed by the member for the support of the dependant during the period of twelve months prior to his death or being incapacitated; provided such assessment shall not exceed the amount specified in column two of the Schedule opposite to the rate of pay of the member.'

Debate ensued.

Amendment, by leave, temporarily withdrawn.

Mr. Hannan moved the following amendment, viz., line 36, after "pensions" insert "providing that such assessment shall not be less than Fifty-two pounds per annum."

Debate ensued.

Amendment negatived.

Clause agreed to.

Clause 8 debated and agreed to.

Clause 9 agreed to.

Clause 10-

On the motion of Mr. Charlton, the following amendment was made, after debate :----

At end of clause add-" Provided that in the case of a pensioner with dependants upon him, the amount forfeited during the term of his imprisonment shall be paid to such dependants.'

Clause, as amended, agreed to.

29th July, 1915.

Clause 11 debated and agreed to. Clauses 12 to 19 inclusive agreed to. Title agreed to. Bill to be reported with an amendment.

The House resumed; Mr. W. Maloney reported accordingly.

On the motion of Mr. Jensen, by leave, the House adopted the Report, and the third reading of the Bill was made an Order of the Day for the next day of sitting.
