### WEDNESDAY, 4TH AUGUST, 1915.

1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.

2. MESSAGES FROM THE GOVERNOR-GENERAL.—ASSENT TO BILLS.—The following Messages from His Excellency the Governor-General were presented, and the same were read by Mr. Speaker :—

3. THE WAR-DETERMINATION TO CONTINUE TO A VICTORIOUS END-Mr. Fisher moved, by leave, That the following Resolution be agreed to :--

"That we, the Representatives of the Commonwealth of Australia, in Parliament assembled, do, on the expiration of a year of war, present to His Majesty our most loyal service, and record our unchanging determination to continue to a victorious end the struggle for the maintenance of the ideals of Liberty and Justice which are the common and sacred cause of the Allied Nations."

Mr. Joseph Cook having seconded the motion-

6. INSCRIBED STOCK BILL (1915).—The Order of the Day having been read for the second reading---Mr. Fisher moved, That the Bill be now read a second time. Debate ensued.

Question-put and passed.-Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

### (In the Committee.)

Clauses 1 to 5 agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed ; Mr. Charlton reported accordingly.

On the motion of Mr. Fisher, the House adopted the Report. Mr. Fisher moved, pursuant to contingent notice, That the Standing Orders be suspended to enable the remaining stage to be passed without delay.

Question—put and passed.

Mr. Fisher moved, That the Bill be now read a third time.

Debate ensued.

Question-put and passed.-Bill read a third time.

7. TREASURY BILLS BILL (1915).-The Order of the Day having been read for the second reading -Mr. Fisher moved, That the Bill be now read a second time. Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Clauses 1 and 2 agreed to. Clause 3 debated and agreed to. Clause 4 agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed; Mr. Charlton reported accordingly.

On the motion of Mr. Fisher, the House adopted the Report.

Mr. Fisher moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stage to be passed without delay.

Question-put and passed.

On the motion of Mr. Fisher, the Bill was read a third time.

8. OFFICERS' COMPENSATION BILL (1915).-The Order of the Day having been read for the second reading-Mr. Fisher moved, That the Bill be now read a second time. Debate ensued.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clause 1 agreed to. Clause 2—On the motion of Mr. Fisher, the following amendment was made, after debate :— Page 1, line 11, after "widow" insert "or children". Clause, as amended, agreed to. Preamble agreed to. Title agreed to. Bill to be reported with an amendment.

The House resumed ; Mr. Charlton reported accordingly.

- On the motion of Mr. Fisher, by leave, the House adopted the Report, and the Bill was read a third time.
- 9. SPECIAL ADJOURNMENT. -- Mr. Fisher moved, That the House, at its rising, adjourn until Wednesday next.

Debate ensued.
