4. MESSAGE FROM THE DEPUTY OF THE GOVERNOR-GENERAL.—WAR LOAN BILL (1916).—The following Message from the Deputy of His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :—  
A. L. STANLEY,  
*Deputy of the Governor-General.* *Message No. 130.*  
In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the raising and expending of the sum of Fifty million pounds for War purposes.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the raising of moneys to be loaned to, and the advancing of moneys to, certain States.

*Deputy of the Governor-General.*

*Message No. 128.*

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the borrowing of money from the Government of the United Kingdom for War purposes.
