FRIDAY, 4TH JULY, 1919.

1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. LEAVE OF ABSENCE TO MEMBER (MR. NICHOLLS).—Mr. Higgs moved, pursuant to notice, That leave of absence for a period of two months be granted to the honorable Member for Macquarie (Mr. Nicholls) on the ground of ill-health.

3. WANT OF CONFIDENCE IN THE GOVERNMENT—MINISTERIAL STATEMENT—MINISTERIAL PROGRAMME.
—The Order of the Day having been read for the resumption of the debate on the motion of Mr. Watt—That the Statement be printed—and on the Amendment moved thereto by Mr. Higgs, viz.:—That after the word "That" there be inserted the words "the Government does not possess the confidence of this House"—
Debate resumed.
