WEDNESDAY, 30TH JULY, 1919.

1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. PAPER.—The following Paper was presented, by command of His Excellency the Governor-General—  
Wool—Report relating to the Activities of the Central Wool Committee for the Wool Season 1918-19, together with various documents in connexion therewith.

Ordered to lie on the Table, and that the Report be printed.

3. ADJOURNMENT—MOTION FOR PURPOSE OF DISCUSSION.—Mr. Boyd rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The entering into contracts for the purchase of ships in England by the Government, without Parliamentary authority".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. Boyd moved, That the House do now adjourn.

Debate ensued.

The time having arrived for the interruption (in accordance with Standing Order No. 119) of the debate—

Sir Robert Best moved, That the debate be continued for one hour.

Mr. McDonald moved, as an amendment, That the words "and a half" be added to the motion. Question—That the words proposed to be added be so added—put.

6. MESSAGE FROM THE SENATE.—TRADE MARKS BILL (1919).—Mr. Speaker announced the receipt of the following Message from the Senate:—

The Senate has passed a Bill for “*An Act to amend the Trade Marks Act 1905-1912*,” and transmits the same to the House of Representatives for its concurrence.

League of Nations—Draft Agreement for—Presented to the Plenary Inter-Allied Conference of, 14th February, 1919. (Paper presented to the British Parliament.)

Ordered to lie on the Table.

The following Papers were presented, pursuant to Statute—

Customs Act—

Proclamation prohibiting the Exportation of Preventives of Conception, &c. (dated 16th July, 1919).

Proclamation (dated 16th July, 1919) revoking Proclamation (dated 4th September, 1918) prohibiting the Exportation (except under certain conditions) of Broom Millet.

Public Service Act—

Appointment of W. J. Penfold, Department of Trade and Customs.

Promotion of H. A. Peterson, Prime Minister's Department.

8. COMMERCIAL ACTIVITIES BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

9. DECLARATION OF COMMERCIAL ACTIVITIES BILL AS URGENT BILL—LIMITATION OF DEBATE.—Mr. Groom having declared that the Commercial Activities Bill was an Urgent Bill—

Question—That the Bill be considered an Urgent Bill—put and passed.

Mr. Groom then moved—

That the time allotted for the further consideration of the Bill in Committee (other than the Schedules, Preamble, and Title) be until 10 o'clock this evening.

That the time allotted for the consideration of the Schedules, Preamble, and Title be until 8.30 p.m. to-morrow.

That the time allotted for the consideration of the remaining stages of the Bill be until 10.30 p.m. to-morrow.

Mr. Tudor moved, as an amendment, That the words "ten o'clock this evening," be omitted with a view to the insertion of the words "four o'clock on Friday afternoon" in place thereof.

Debate ensued.

Question—That the words proposed to be omitted stand part of the question—put.

10. COMMERCIAL ACTIVITIES BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House again resolved itself into a Committee of the Whole.

(*In the Committee.*)

Clause 6 further considered.

Mr. Riley moved, as an amendment, That the following sub-clause be added to the clause :—

"(4.) The Government of the Commonwealth shall pay to the employees of the Colonial Combing, Spinning, and Weaving Company Limited, and Whiddon Brothers Limited, twenty per cent. of the net earnings received from the said companies under agreements between the Government and the companies, the said twenty per cent. to be distributed amongst the employees in such sums and in such manner as a committee of ten persons appointed by the employees may decide."

Debate ensued.

*Limitation of Debate.*—At six o'clock p.m. the Chairman having called the attention of the Committee to the fact that the time allotted for the Committee stage (other than the Schedules, Preamble, and Title) of the Bill had expired—
