## FRIDAY, 12TH SEPTEMBER, 1919.

- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PRESENTATION OF BIBLE TO PARLIAMENT.—Mr. Speaker informed honorable Members that, at ten minutes past two that afternoon, in the North Library, His Excellency the Governor-General, on behalf of the British and Foreign Bible Society, would present to this Parliament a Bible and lectern to commemorate the signing of peace.
  - Mr. Speaker added that he would be glad if honorable Members would attend at the ceremony.
- 3. Supply Resolution [Supply Bill].—The House, according to Order, resolved itself into the Committee of Supply.

#### (In the Committee.)

SUPPLY BILL (No. 2) 1919-20.

Debate resumed on the following motion of Mr. Poynton—That there be granted to His Majesty for or towards defraying the services of the year 1919-20 a sum not exceeding £6,088,542.

Mr. Tudor moved, as an amendment, That the amount be reduced by £1.

Debate ensued.

Question—That the amount proposed to be reduced be so reduced—put.

- 5. Supply Resolution.—The Resolution reported from the Committee of Supply was read, and, on the motion of Mr. Groom, was adopted by the House.
- 6. Ways and Means Resolution.—The House, according to Order, resolved itself into the Committee of Ways and Means.

### (In the Committee.)

Supply Bill (No. 2) 1919-20.

Resolved, on the motion of Mr. Groom—That, towards making good the Supply granted to His Majesty for the services of the year 1919-20, there be granted out of the Consolidated Revenue Fund a sum not exceeding £6,088,542.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Bamford reported accordingly.

Resolved—That the House will, on Wednesday next, again resolve itself into the said Committee.

The Resolution reported from the Committee was read, and, on the motion of Mr. Groom, was adopted by the House.

Ordered—That Mr. Hughes and Mr. Groom do prepare and bring in a Bill to carry out the foregoing Resolution.

7. Supply Bill (No. 2) 1919-20.—Mr. Groom then brought up a Bill intituled "A Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and twenty," and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Groom moved, That the Bill be now read a second time.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Bill agreed to, and to be reported without amendment.

The House resumed; Mr. Bamford reported accordingly.

On the motion of Mr. Groom, the House adopted the Report, and the Bill was read a third time.

8. Papers.—The following Papers were presented, by command of His Excellency the Governor-General— Papers presented to the British Parliament:—

Education—Third Interim Report of the Adult Education Committee—Libraries and Museums.

Labour—Interim Report of the Committee of Inquiry into the Scheme of Out-of-Work Donation.

League of Nations—Covenant, with a Commentary thereon.

War Savings Committee (National)—Third Annual Report—2nd June, 1919.

Women's Advisory Committee—Report of the Sub-Committee appointed to consider the position after the War of women holding temporary appointments in Government Departments.

Peace Treaty-Bill introduced into the British Parliament.

Severally ordered to lie on the Table.

9. ADJOURNMENT.-Mr. Groom moved, That the House do now adjourn.

Debate ensued.

Question—put and passed.

And then the House, at four minutes to five o'clock p.m., adjourned until Wednesday next, at three o'clock p.m.
