Resolved, on the motion of Mr. Watt-That it is expedient that an appropriation of moneys be made for the purposes of a Bill for an Act to authorize the Raising and Expending of the sum of One million one hundred and seven thousand six hundred and two pounds for certain purposes.

The House resumed; Mr. Chanter reported accordingly.

Mr. Watt moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

The said Resolution was read, and, on the motion of Mr. Watt, was adopted by the House.

Ordered-That Mr. Watt and Mr. Poynton do prepare and bring in a Bill to carry out the foregoing Resolution.

Message No. 103.

In accordance with the requirements of section Fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue and moneys be made for the purposes of a Bill for an Act to authorize the raising of moneys for paying off, repurchasing or redeeming certain Debentures issued by the State of Tasmania.

Question—put and passed.

Mr. Groom brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for to-morrow.

10. Excise Tariff Validation Bill (1919).—Mr. Groom moved, pursuant to notice, That he have leave to bring in a Bill for an Act to provide for the Validation of Collections of Duties of Excise under Tariff Proposals.

Question—put and passed.

Mr. Groom brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for to-morrow.

11. TASMANIAN LOAN REDEMPTION BILL.—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 103-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Chanter reported accordingly.

Resolved-That the House will, to-morrow, again resolve itself into the said Committee.

13. Adjournment.—Mr. Greene moved, That the House do now adjourn.

Debate ensued.

Question—put and passed.

And then the House, at fourteen minutes past eleven o'clock p.m., adjourned until to-morrow at eleven o'clock a.m.
