FRIDAY, 17TH OCTOBER, 1919.

- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Adjournment-Motion for Purpose of Discussion.—Mr. McGrath rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The proposed gratuities to returned soldiers and sailors."

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. McGrath moved, That the House do now adjourn.

Debate ensued.

Question—put and negatived.

- 3. Paper.—The following Paper was presented, by command of His Excellency the Governor-General—

 Economies—First Progress Report of the Royal Commission appointed to consider and report

 upon the Public Expenditure of the Commonwealth with a view to effecting Economies.

 Ordered to lie on the Table, and to be printed.
- 4. Additional Day of Meeting.—Sir Joseph Cook moved, That the House, at its rising, adjourn until Tuesday next, at three o'clock p.m. Question—put and passed.
- 5. Message from the Senate.—Electoral Bill (1919).—Mr. Speaker announced the receipt of the following Message from the Senate:—

The Senate has passed a Bill for "An Act to amend the 'Commonwealth Electoral Act 1918'," and transmits the same to the House of Representatives for its concurrence.

Question—put and passed.

Clause 8 debated and agreed to.
Clauses 9 to 21 agreed to.
Clause 22 debated and agreed to.
Title agreed to.
Bill to be reported without amendment.

The House resumed; Mr. Chanter reported accordingly.

On the motion of Mr. Glynn, the House adopted the Report.

Mr. Glynn moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stage to be passed without delay.

Question—put and passed.

9. Matrimonial Causes (Expeditionary Forces) Bill.—The Order of the Day having been read for the second reading—Mr. Groom moved, That the Bill be now read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
