- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Message from the Deputy of the Governor-General.—Assent to Bill.—The following Message from His Excellency the Deputy of the Governor-General was received, and the same was read by Mr. Speaker:—

A Bill intituled "Butter Agreement Act 1920," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Deputy of the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

3. Message from the Deputy of the Governor-General.—Arbitration (Public Service) Bill (1920).—The following Message from His Excellency the Deputy of the Governor-General was presented, and the same was read by Mr. Speaker:—

Message No. 25.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Deputy of the Governor-General recommends to the House of Representatives an appropriation of the Consolidated Revenue Fund for the purposes of an amendment providing for the salary of the Arbitrator in a Bill for an Act relating to the settlement of matters arising out of employment in the Public Service.

7th September, 1920.

Ordered—That the consideration of the foregoing Message, in Committee of the whole House, be made an Order of the Day for a later hour this day.

4. 5. Arbitration (Public Service) Bill (1920).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed.

Mr. Ryan moved, as an amendment, That the following words be inserted after the word "now":—
"withdrawn for the purpose of affording an opportunity to the members of the Public Service of indicating whether they desire to be removed from the jurisdiction and protection of the Commonwealth Court of Conciliation and Arbitration as proposed by the Bill".

Debate continued.

Mr. R. W. Foster moved, That the debate be now adjourned. Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for to-morrow.

6. Arbitration (Public Service) Bill (1920).—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Deputy of the Governor-General's Message No. 25—

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Resolved, on the motion of Mr. Groom, after debate—That it is expedient that an appropriation of the Consolidated Revenue Fund be made for the purposes of an amendment providing for the salary of the Arbitrator in a Bill for an Act relating to the settlement of matters arising out of employment in the Public Service.

Resolution to be reported.

The House resumed; Mr. Chanter reported accordingly.

The said Resolution was read, and, on the motion of Mr. Groom, was adopted by the House.

7. Adjournment.—Sir Joseph Cook moved, That the House do now adjourn.

Debate ensued.

Question-put and passed.

And then the House, at seven minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
