1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. PAPERS.—The following Paper was presented, by command of His Excellency the Governor-General—

3. MINISTERIAL STATEMENT *RE* IMPERIAL CONFERENCE—MANDATE FOR GERMAN POSSESSIONS IN THE PACIFIC—MOTION FOR PRINTING PAPER.—Mr. Hughes, by leave, made a Ministerial Statement with reference to the Imperial Conference, which it was proposed to hold in Great Britain shortly, and in conclusion, by command of His Excellency the Governor-General, laid upon the Table the following Paper—
League of Nations—Mandate for German possessions in the Pacific Ocean situated south of the Equator other than German Samoa and Nauru,
and moved, That the Paper be printed.
Mr. Tudor moved, That the debate be now adjourned.
Mr. Watt, by leave, supported the motion for adjournment.
Question—That the debate be now adjourned—put and passed.
Ordered—That the resumption of the debate be made an Order of the Day for Wednesday next.
