POYNTON).—Sir Joseph Cook moved, by leave, That leave of absence for one month be given to the honorable Member for Lang (Sir Elliot Johnson), on the ground of ill-health, and to the honorable Member for Grey (Mr. Poynton), on the ground of urgent public business.
