- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was received, and the same was read by Mr. Speaker:—

6. Meat Export Bounties Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed.

Mr. Jowett addressing the House, and not having concluded his speech at the termination of the time allowed by Standing Order No. 257A, the honorable Member was given leave to continue his speech for a few minutes.

Debate continued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Clauses 1, 2, and 3 agreed to.

Clause 4 debated.

Mr. Jowett moved, as an amendment, That the following paragraph be inserted after paragraph (a):-

"(aa) the export from the Commonwealth, on or before the thirty-first day of May, One thousand nine hundred and twenty-three, of standard beef exported in fulfilment of any contract which has already been made providing for the shipment of beef monthly or at shorter intervals:"

Amendment ruled out of order on the ground that its effect would be to increase the amount of the appropriation required.

Clause further debated, and agreed to.

Clauses 5, 6, and 7 agreed to.

Clause 8 debated and agreed to.

Clauses 9 to 12 agreed to.

Preamble agreed to.

Title agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Chanter reported accordingly.

On the motion of Mr. Rodgers, the House adopted the Report, and, by leave, the Bill was, after debate, read a third time.

11. Message from the Deputy of the Governor-General.—Defence Retirement Bill.—The following Message from His Excellency the Deputy of the Governor-General was presented, and the same was read by Mr. Speaker:—

Message No. 16.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Deputy of the Governor-General recommends to the House of Representatives an appropriation of the Consolidated Revenue Fund for the purposes of amendments to the Defence Retirement Bill, to be moved by the Minister for Defence, in relation to the amount of compensation payable under that Bill.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Resolved, on the motion of Mr. Greene, after debate—That it is expedient that an appropriation of the Consolidated Revenue Fund be made for the purposes of amendments to the Defence Retirement Bill, to be moved by the Minister for Defence, in relation to the amount of compensation payable under that Bill.

Resolution to be reported.

The House resumed; Mr. Chanter reported accordingly.

Ordered—That the Report be considered at once.

The said Resolution was read, and, on the motion of Mr. Greene, was adopted by the House.

12. Defence Retirement Bill.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Postponed clause 5-

On the motion of Mr. Greene, after debate, the following amendment was made :-

Lines 35-38, omit "(not being a person whose duties, in the opinion of the Naval Board of Administration, the Military Board of Administration, or the Air Board, as the case may be, have been mainly of a purely clerical nature)"; insert "or of any employee holding on or before the thirtieth day of June, One thousand nine hundred and twenty-two, a classified office in the Defence Department, who has not attained the age of sixty-five years."

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Chanter reported accordingly.

Resolved—That the House will, at its next sitting, again resolve itself into the said Committee.

13. ADJOURNMENT.—Mr. Greene moved, That the House do now adjourn.

Debate ensued.

Question—put and passed.

And then the House, at twenty-nine minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
