## THURSDAY, 28TH SEPTEMBER, 1922.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Income Tax Assessment Bill (1922).—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:-

FORSTER,

Governor-General.

Message No. 26.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to consolidate and amend the Law relating to the Imposition Assessment and Collection of a Tax upon Incomes.

Ordered—That the consideration of the foregoing Message, in Committee of the whole House, be made an Order of the Day for a later hour this day.

4. RAILWAY GAUGE BILL .-- Mr Hughes moved, pursuant to notice, That he have leave to bring in a Bill for an Act relating to the Unification of Railway Gauges in Australia.

Question—put and passed.

Mr. Hughes brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for the next sitting.

5. Customs Bill (1922).—The Order of the Day having been read for the second reading—Mr. Rodgers moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Bill agreed to, after debate, and to be reported without amendment.

The House resumed; Mr. Watkins reported accordingly.

On the motion of Mr. Rodgers, the House adopted the Report, and, by leave, the Bill was read a third time.

Ordered—That the Report be considered at once.

The said Resolution was read, and, on the motion of Mr. Bruce, was adopted by the House.

7. Public Service Bill (1922).—The Order of the Day having been read for the second reading— Mr. Groom moved, That the Bill be now read a second time. Mr. Charlton moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered - That the resumption of the debate be made an Order of the Day for a later hour this day.

8. WAR SERVICE HOMES BILL (1922).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
