- 2. Days of Business—Alteration of.—Mr. Bruce (Prime Minister) moved, by leave, That, unless otherwise ordered, this House shall meet for the despatch of business at three o'clock on each Wednesday afternoon, at half-past two o'clock on each Thursday afternoon, and at eleven o'clock on each Friday morning.

 Question—put and passed.
- 3. General Business—Precedence to on Thursdays until 6.30 p.m.—Mr. Bruce (Prime Minister) moved, by leave, That, on each Thursday, unless otherwise ordered, General Business shall take precedence of Government Business until half-past six o'clock p.m. Question—put and passed.
- 4. Leave of Absence to Member (Mr. Hughes).—Mr. Bruce (Prime Minister) moved, by leave, That leave of absence for one month be given to the Right Honorable Member for North Sydney (Mr. Hughes), on the ground of urgent private business.

- 5. Leave of Absence to Member (Mr. Charles McDonald).—Mr. Charlton (Leader of the Opposition) moved, by leave, That leave of absence for three months be given to the honorable Member for Kennedy (Mr. Charles McDonald), on the ground of ill-health.

8. Ordered to lie on the Table.

Sir Littleton Groom (Attorney-General) moved, That the Paper be printed. Sir Littleton Groom not having concluded his speech, the House ordered that the honorable Member have leave to continue his speech when the debate is resumed.

Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.

10. Canned Fruit Bounty Bill.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Deputy-Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
