- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Right Honorable W. A. Watt) took the Chair, and read Prayers.
- MINISTERIAL STATEMENT—TAXATION OF CROWN LEASEHOLDS.—Mr. Earle Page (Treasurer), by leave, made a Ministerial Statement with reference to the Taxation of Crown Leaseholds.
 Mr. Charlton (Leader of the Opposition), by leave, also made a statement with reference to the matter.
- 3. Paper.—The following Paper was presented, by command of His Excellency the Governor-General—

- 5. AIRCRAFT DÉPÔT, LAVERTON—APPROVAL OF WORK.—Mr. Stewart (Minister for Works and Railways) moved, pursuant to notice, That, in accordance with the provisions of the Commonwealth Public Works Committee Act 1913-21, it is expedient to carry out the following work:—The establishment of an Aircraft Dépôt, with accessory services, at Laverton, Victoria, which work was referred to the Parliamentary Standing Committee on Public Works, and on which the Committee has duly reported to this House the result of its investigations.

- 6. OIL AGREEMENT BILL (1924).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
 - Debate resumed by Mr. Blakeley, who moved, as an amendment, That all the words after the word "That" be omitted with a view to the insertion of the following words in place thereof:—"the Bill be withdrawn and that a Royal Commission be appointed to inquire into and report upon the operations of the Anglo-Persian Oil Company in New Guinea and the Commonwealth Oil Agreement".

Question—That the words proposed to be omitted stand part of the question—put.
