Message No. 49.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund a sum for War Pensions.

6. CATTLE EXPORT BOUNTY BILL.—The Order of the Day having been read for the consideration in Committee of the whole House of His Excellency the Governor-General's Message No. 47-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Pratten (Minister for Trade and Customs) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the Payment of a Bounty on the Export of Live Cattle.

The Resolution reported from the Committee was read, and, on the motion of Mr. Pratten, was adopted by the House.

Iron and Steel Products Bounty Act—Statement setting out particulars relating to approval given for the use of imported materials in the manufacture of products upon which bounty may be paid.

11. Adjournment.—Mr. Bruce (Prime Minister) moved, That the House do now adjourn. Debate ensued.
