### **76.01** *Updated Ministry presented*

Before Question Time on 9 March, the Prime Minister presented a copy of the Rudd Ministry list as at 9 March 2009. The document was incorporated into *Hansard*.

## **76.02** Statements by indulgence on floods, visit by Indonesian President and long serving Member

Prior to Question Time on 9 March the Prime Minister and the Leader of the Opposition made statements by indulgence regarding the current flooding in Queensland, after which both also made statements by indulgence on the visit by the President of Indonesia. The Leader of the Opposition then made a statement by indulgence to acknowledge that the Member for Berowra had become the third longest serving Member of the House. The Prime Minister and the Member for Berowra also commented on the milestone by indulgence.

## 76.03 Arrangements for address by Indonesian President

On 9 March, the House agreed to a motion moved by the Leader of the House, by leave, concerning arrangements for an address to be made to the House of Representatives on 10 March by His Excellency, Dr Susilo Bambang Yudhoyono, President of the Republic of Indonesia. The motion included provision for a message to be sent to the Senate inviting Senators to attend the House as guests. A further provision extended the powers of the Speaker in respect of visiting Senators from those seated in the Senators' gallery to those in other galleries and on the floor of the House. #### **76.04** Address by Indonesian President

On 10 March, in accordance with the resolution of the previous sitting (*see* entry **76.03**), the House suspended at 11.44 a.m., and resumed upon the ringing of the bells at 2.30 p.m. After taking the Chair, the Speaker welcomed the President and Senators to the sitting of the House.

Following welcoming remarks from the Prime Minister and the Leader of the Opposition, the Indonesian President, His Excellency Dr Susilo Bambang Yudhoyono, addressed Members and Senators.

After President Yudhoyono had left the Chamber, the Speaker suspended the sitting until the ringing of the bells. The sitting resumed at 4.15 p.m. and business proceeded in accordance with the resolution of the previous sitting.

*Note:* This was a sitting of the House, not a joint meeting of the two Houses. Senators had been invited (by way of a message) to attend as guests.

Additional note: The Speaker entered the Chamber through the Members' Hall entrance.

## **76.12** Suspension of standing orders – Debate on health policy during Question Time

During Question Time the Leader of the House moved a suspension of standing and sessional orders to allow the Leader of the Opposition to speak for 10 minutes on health policy and the Prime Minister to respond for an equal amount of time. The question was agreed to on the voices, with the concurrence of an absolute majority. The Leader of the Opposition spoke for ten minutes, and was then granted an extension of time on a motion by the Leader of the House. The Prime Minister then made his remarks, after which Question Time resumed.

*Note:* A suspension motion moved without notice must be relevant to any business under discussion and can only be carried by an absolute majority of Members.

Further note: Another Member may move that a Member whose speech is interrupted (because the allotted time has expired) be granted an extension of time. If the motion is carried then the speech can continue for up to 10 minutes or half the original period allotted, whichever is shorter.

## Privilege

76.20 Matter of privilege raised – Photograph taken in the Chamber

Following prayers on 18 March, an Opposition Member raised as a matter of privilege a photograph taken of him in the Chamber and its subsequent publication, and presented three newspaper articles. He noted that it was clear from an examination of the photograph that it could only have been taken from very close to where he was sitting, and asked that a forensic examination of the photograph be conducted to ascertain the identity of the photographer. The Member stated that the taking and publication of the photograph seriously interfered with his ability to carry out his duties as a Member, and asked the Speaker to consider referring the matter to the Committee of Privileges and Members' Interests.

The Speaker advised that he would consider the matter and report back to the House, noting that the taking of such a photograph would be outside the guidelines for photography in the Chamber and that any Member found to have

used a mobile device to take a photograph during proceedings would be subject to disciplinary action by the House.

Later in the sitting, the Speaker made a statement regarding the matter of privilege. He noted that he could understand that the publication of the photograph was embarrassing to the Member and might influence the views of his constituents. The Speaker indicated, however, that in the absence of more specific evidence of the effect that this has had on the free performance of the Member's duties, he had not found that a prima facie case of privilege had been established. He further advised that as a preliminary examination of the Chamber footage to determine who had taken the photograph was inconclusive, he did not propose to agree to further forensic examination.

Following the Speaker's statement, the Leader of the House moved the referral of a matter to the Committee of Privileges and Members' Interests, namely: 'Having regard to the matter complained about by the honourable Member for Fisher, whether formal rules should be adopted by the House to ensure that the use of mobile devices during proceedings does not interfere with the free exercise by a House or a committee of its authority or functions or with the free performance by a member of his or her duties as a Member.' Following debate, during which a motion 'that the question be put' was moved by the Leader of the Opposition and negatived on division, the motion for referral to the Committee was agreed to on the voices.

*Note:* The photograph's publication had initially been raised by a Government Member a week earlier (*see* entry **76.23**).

The Member continued to attempt to receive the call, and the Speaker interrupted the Minister to explain that he had not recognised the Member on this occasion, noting that the Member had a history of abusing the right to raise a point of order. The Speaker added that his decision was in line with the practice of previous Speakers.

In response to a question from the Member following Question Time, the Speaker advised that while he did not intend to take such action often, he would not be reviewing his decision.
