Bills

77.01 Presentation of Budget and additional appropriation bills, including explanatory memoranda

On 11 May, the Treasurer presented Appropriation Bill (No. 1) 2010-2011, moved the second reading and delivered the budget speech. After the Treasurer had presented associated documents and statements, the Minister for Finance and Deregulation presented Appropriation Bill (No. 2) 2010-2011 and Appropriation (Parliamentary Departments) Bill (No. 1) 2010-2011. An explanatory memorandum was presented with each of these bills.

The Speaker announced receipt of a message from the Governor-General recommending appropriation before each bill was presented.

Note: Explanatory memoranda are not required for budget bills under the standing orders.

77.02 Bill returned to House with unresolved question

A report was received from the Main Committee returning the Veterans' Entitlements Amendment (Income Support Measures) Bill 2010 with an unresolved question on an Independent Member's second reading amendment. The unresolved question (that the words proposed to be omitted stand part of the question) was proposed and, after debate, was agreed to on division with fewer than five Members on the side of the noes. The bill was read a second time, and on a motion by a Minister was then read a third time.

The sitting was immediately suspended, at approximately 6 p.m. When the sitting was resumed at 7.30 p.m., the Leader of the Opposition was called on immediately and delivered the Budget reply speech.

Note: In previous years the bill has been called on upon resumption of the sitting, causing a short delay to the start of the Leader of the Opposition's nationally broadcast Budget reply speech.
