### **59.01** Election petition dismissed by Court of Disputed Returns

The Clerk presented a letter from the Registrar of the Federal Court, forwarding a copy of an order made by the Federal Court of Australia sitting as the Court of Disputed Returns dismissing the petition relating to Mitchell *v.* Bailey (*see* entry **55.08**).

# 59.13 Deferred divisions on two orders of the day

The second reading debate on the Trade Practices Legislation Amendment Bill 2008 concluded at about 6.40 p.m. on 1 September. A division called for on a second reading amendment was deferred until after 8 p.m. The second reading debate on the next order of the day, the Families, Housing, Community Services and Indigenous Affairs and Other Legislation Amendment (Emergency Response Consolidation) Bill 2008 concluded at about 7.45 p.m., and again a division called for on a second reading amendment was deferred until after 8 p.m. The House then resumed debate on another bill.

When the Member speaking at 8 p.m. had concluded his speech, debate on the bill before the House was adjourned and the House returned to the previous orders of the day for the deferred divisions. The second reading amendment for the first bill was negatived on division, and the remaining stages were agreed to on the voices. The second reading amendment for the second bill was also negatived on division, but debate was then interrupted (the time being past 8.30 p.m.) to call on

presentation of petitions. Resumption of debate was made an order of the day for the next sitting.
