**82.01** Opposition amendment moved to Senate amendments; further amendment ruled out of order

Having resumed the sitting of Thursday 25 November which was suspended over the weekend (See entry 82.13), the House considered Senate amendments to the Telecommunications Legislation Amendment (Competition and Consumer Safeguards) Bill 2010. A Minister moved that the amendments be agreed to. An Opposition Member moved an amendment to one of the Senate amendments. Following debate, the amendment was negatived on division. The same Opposition Member then moved another amendment. The Speaker ruled the amendment out of order as it was consequent on the earlier amendment, which had been negatived.

The question that the Senate amendments be agreed to was then debated. A motion by an Independent Member that the question be put was negatived on division, and following further debate the question was agreed to on the voices.

# 82.30 Deferred divisions not to interrupt speeches

During the division the Speaker, who had since taken the Chair, advised the House that it had been the practice to allow a Member who was speaking at the end of the period of deferred divisions to complete their speech before any deferred divisions were proceeded with.

# 82.31 Tied vote on amendment to suspension of standing orders – Speaker gives casting vote

The question that the original motion be agreed to was then put again, and agreed to on the voices.

*Note:* If a question that the words proposed to be omitted stand part of the question is negatived, the next question to be put is that the words proposed to be inserted (i.e. by the amendment) be so inserted.

If the motion is carried then the speech can continue for up to 10 minutes or half the original period allotted, whichever is shorter. Under the amended standing orders (*see* entry **80.25**), time limits apply of 45 seconds per question and 4 minutes per answer.

If the motion is carried then the speech can continue for up to 10 minutes or half the original period allotted, whichever is shorter. Under the amended standing orders (*see* entry **80.25**), time limits apply of 45 seconds per question and 4 minutes per answer.

Following Question Time, three questions were asked of the Speaker in relation to his administrative responsibilities. The first question related to the water features at Parliament House, and the Speaker advised that attempts were being made to reinstate several of the water features, which may incorporate the harvesting of water from the air-conditioning towers.

The second question related to the resourcing of the Parliamentary Library, to which the Speaker responded that a study would be undertaken into the resourcing of the Library and the House committee system, and that preliminary bids for additional resourcing had been made.

The third question raised the noise caused by the use of lawnmowers and other machinery outside Members' offices between 7 a.m. and 9 a.m. on sitting days. The Speaker replied that he would take up the matter with the Department of Parliamentary Services.
