### 40th Parliament

The 40<sup>th</sup> Parliament will be opened tomorrow by the Governor-General in the Senate chamber (*see* pages 2 and 3 for an outline of the program). The Address-in-reply (the Senate's response to the Governor-General's speech) is programmed for debate in the Senate for the remainder of the week.

### Legislation

The government has indicated it will introduce a number of bills into the Senate on Wednesday 13 February 2002. Only one bill, the Regional Forest Agreements Bill 2002, is listed for debate on Thursday 14 February 2002.

## **OPENING OF PARLIAMENT 12 FEBRUARY 2002**

The major events, and approximate times of the events, associated with the Opening of Parliament on Tuesday, 12 February 2002 will be:

### ***Morning Proceedings***

- 10.15 am Forecourt/Foyer - arrival of the Deputy of the Governor-General, the Hon Murray Gleeson AC, Chief Justice of the High Court of Australia, and Mrs Gleeson.
- 10.30 am Senate and House of Representatives assemble.
- 10.40 am Senate Chamber – The Deputy addresses both Houses and opens the Parliament.
- 10.45 am Senate Chamber - Swearing-in of territory and new senators.
- 10.55 am House of Representatives Chamber - Swearing-in of members. (approx.)
- 11.35 am House of Representatives Chamber - Election of Speaker. (approx.)  
Foyer/Forecourt - The Deputy and Mrs Gleeson depart Parliament House.

*(For the morning proceedings staff and members of the public are welcome to view proceedings in the public galleries of the Senate. Seats will be allocated on a first come, first served basis. The public galleries in the House of Representatives will be occupied by invited guests but limited seating will be available in the second floor glazed galleries).*

## ***Afternoon Proceedings***

2.00 pm Forecourt – His Excellency the Governor-General, the Right Reverend Dr Peter Hollingworth AC OBE and Mrs Hollingworth arrive. The Governor-General receives the Royal Salute and inspects the Guard and Band.

2.25 pm House bells ring.

2.30 pm Members Hall - The Speaker and Members of the House of Representatives are presented to the Governor-General and Mrs Hollingworth.

2.55 pm Senate bells ring.

3.00 pm Senate Chamber - The Governor-General addresses both Houses.

3.40 pm Federation Mall - 19 Gun Salute.  
(approx.)

3.50 pm Members Hall - Afternoon Tea is served to invited guests.

4.30 pm Forecourt - The Governor-General and Mrs Hollingworth depart Parliament House.

*(For the afternoon proceedings access to galleries in the Senate Chamber is restricted to invited guests. Events will be screened on the house monitoring system from 1.50 pm on channels 1, 2 & 12 and in the Theatrette).*

5.00 pm Senate and House of Representatives assemble (both chambers open to the public).

During the various events connected with the Opening, areas of the building will be closed to all but participants and invited guests. We ask for the co-operation of all occupants of the building when areas of the building are closed for ceremonies and processions.
