The Minister representing the Treasurer gave and tabled the Budget statement for the year 2002-03 and also tabled [associated budget papers](#) and ministerial statements. The Opposition, minor parties and independent senators will make their responses to the Budget statement on Thursday 16 May 2002.

The Senate [agreed to a motion](#) by the Minister representing the Treasurer to refer documents to legislation committees to enable the committees to examine the proposed budget. This initiates the [estimates hearings process](#). The committees are due to report to the Senate on 19 June 2002.
