# Legislation

## **Bills considered**

The following bills were introduced

- □ Carbon Pollution Reduction Scheme Bill 2010 and 10 related bills [passed by the House of Representatives on 11 February 2010] [a motion for the bills to proceed without formalities was debated and negatived – <u>first speaker</u>. As a result, subsequent stages of the passage of the bills must now take place on different days. See standing orders <u>112</u>, <u>114</u>, <u>120</u> and <u>122</u>]
- □ International Tax Agreements Amendment Bill (No. 2) 2009 [passed by the House of Representatives on 10 February 2010]
- National Health Security Amendment (Background Checking) Bill
  2009 [passed by the House of Representatives on 11 February 2010]
- □ Tax Laws Amendment (2009 Measures No. 6) Bill 2009 [passed by the House of Representatives on 10 February 2010]
