The Leader of the Government in the Senate (Senator Hill), by leave, moved—That the Senate records its deep regret at the death, on 27 July 2004, of the Honourable Dr Henry Alfred Jenkins, AM, former Speaker of the House of Representatives and member for Scullin, and places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his family in their bereavement.

The motion was supported and all senators present stood in silence-

Question passed.

#### 13 DEATH OF FORMER MEMBER BARRY DOUGLAS SIMON

The President informed the Senate of the death, on 7 July 2004, of Barry Douglas Simon, a member of the House of Representatives for the division of McMillan from 1975 to 1980.

The President, from 32 petitioners, requesting that the Senate take action to ensure priority funding to public schools to enable them to continue to provide high quality education to all, regardless of wealth, location, ethnicity, religion or special needs.

Senator Allison, from 41 petitioners, requesting that the Senate amend any proposed legislation relating to Medicare to ensure that equitable access to doctors' services is preserved.

Senator Bartlett, from 26 petitioners, requesting that the Senate call on the Government to initiate a Royal Commission into sexual assault and the abuse of children.

Senators Bartlett, O'Brien, Patterson, Ridgeway and Troeth, from 74, 20, 47, 36 and 12 petitioners, respectively, requesting that the Senate oppose any legislation to abolish the Aboriginal and Torres Strait Islander Commission.

Senator Nettle, from 15 petitioners, requesting that the Senate take action to ensure that Mamdouh Habib's rights are acknowledged and that he be returned to Australia and entitled to a civil trial if charged with any crime.
