1 MEETING OF SENATE

The Senate met at 9.30 am. The President (Senator the Honourable Paul Calvert) took the chair and read prayers.

2 **PETITIONS**

The following 4 petitions, lodged with the Clerk by the senators indicated, were received:

Senator Bartlett, from 436 petitioners, requesting that the Senate take action to urge the Chinese Communist Party to release all detained Falun Gong practitioners, to establish an inquiry into the allegation of organ harvesting and to discourage Australian citizens from travelling to China for organ transplants.

Senator Hogg, from 77 petitioners, requesting that the Senate call on the Prime Minister to sign the Kyoto agreement on behalf of the citizens of Australia and move to implement safe policies that will ensure Australia achieves the targets set out in the agreement.

Senator Hogg, from 242 petitioners, requesting that the Senate take action to ensure that enough medical professionals are trained to maintain the quality care provided by hospitals and other health services.

Senator Wong, from 49 petitioners, requesting that the Senate legislate to create an offence of transmission by mail of child pornography and child abuse material.

21 ANTI-MONEY LAUNDERING AND COUNTER-TERRORISM FINANCING AMENDMENT BILL 2007
