Attached is a copy of my letter to the Australian Electoral Commission in relation to the recent Aston by-election, together with a copy of their reply, advising that such a change is outside the role of the A.E.C. Enclosed also with their reply were copies of the A.E.C. By-elections and Referendum Fact Sheets.

Page 7 of the fact sheet showr that in the May 1977 Referendums 73.32% voted in favour of Senate Casual Vacancies being filled by a person of the same political party for the balance of the term.

As per the copy of my letter attached, I respectfully suggest that the whole By-election process be reviewed to enable the House of Representatives Casual Vacancy to be filled in a similar manner to that of the Senate.

Therefore as Mr. Nugent was an endorsed major party candidate, and not an "Independent," surely, from a commonsense point of view, and, also in fair ness to the people of Aston, the vacancy should be filled by a member of that major party for the remaining period of the Government of the day.

I fully agree that such a simple scheme would not be applicable if the seat were to be held by on "Independent" and I accept that in such a case a by election would be necessary.
