# Question on Notice Colin Walters, International Education Division

#### QUESTION

**Mr Walters**: For example, in the education space you will always get comparisons with the British Council, which is probably a world leader in terms of having an educational promotion organisation but with a much wider remit, because they do cultural things as well.

CHAIR: Can you send us some information about what they do?

**Mr Walters:** Yes, gladly. I would simply make the point they have much larger resources. I think they have 40 staff in Hong Kong alone, whereas we have one locally employed person.

**CHAIR:** Are they government funded?

**Mr Walters:** Not entirely, actually, and that is a point which people often misunderstand. They have an income stream that comes from running things like examination sessions. Across the world, English language exams are actually a big industry sector, if you like, because people need English language qualifications to get into colleges and universities. A lot of that is run in association with the British Council, but they also conduct a lot of the examinations. Together with IDP Australia, they helped to develop the IELTS system, which is one of the leading systems for assessing people's English language competency. That brings them quite a big income stream. In Australia, all that work is done privately. We have done a little bit in the past, but it is not a major income stream for us as it is with the British Council.
