DEAR SIR.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY NOT BE RATIFIED . WE DO NOT SUPPORT THE EVASION OF TAXATION BY THOSE MULTINATIONALS WHO ARE REGISTERED IN TAX HAVENS OVERSEAS, ALSO WE DO NOT SUPPORT THE CONCEPT THAT NO TAX IS PAID BY THESE MULTINATIONALS ON PROFITS ,WHILE AUSTRALIANS ARE THE MOST TAXED RACE ON EARTH . AS POINTED OUT IN A PREVIOUS SUBMISSION THE TAX OFFICE , ( ATO ) ADMIT THAT THEY ARE NOT A LEGAL ENTITY. ARTICLE 13 . SPEAKS ONCE AGAIN OF REAL PROPERTY , ONCE AGAIN WE REMIND THE PARLIAMENT OF FEE SIMPLE ON ALL LAND TITLE . THERE CAN BE NO BENEFIT TO THE CROWN ON FEE SIMPLE PROPERTY , IE: STAMP DUTY, LAND RATES . UNDER HIGH COURT RULINGS THERE CANNOT BE ANY CHARGES ON PROPERTY . UNDER LAW THERE CAN BE NO ALIENATION EXECEPT IN TOTAL . ALL MINERALS , OIL , OR ANY OTHER WEALTH UNDER THE GROUND IS TOTALLY OWNED BY THE DEED HOLDER , NOT ONLY IS FEE SIMPLE TENURE ON PROPERTY , BUT IT IS ALSO INTERNATIONAL

LAW, THE REAL PROPERTY ACT SPEAKS OF FEE SIMPLE AS BEING TOTAL OWNERSHIP OF PROPERTY. FEE SIMPLE TENURE IS A CONTRACTUAL AGREEMENT BETWEEN YOURSELF AND THE PREVIOUS OWNER, NO THIRD PARTY CAN GET INVOLVED, IE: COUNCILS. THE FEDERAL REFERENDUM 3<sup>RD</sup> SEPT 1988. ON LOCAL GOVERNMENT WAS REJECTED BY THE PEOPLE, REGONITION OF THE LOCAL GOVERNMENT ACT, WAS DENIED. ALL COUNCILS HAVE SINCE BEEN WITHOUT LEGAL VALIDITY SINCE THAT DATE. THIS SECTION OF THIS TREATY IS WRONG UNDER AUSTRALIAN LAW, AND UNDER INTERNATIONAL LAW. NO PROFITS CAN BE DERIVED FROM PROPERTY UNDER FEE SIMPLE. THE TERM AUSTRALIAN GOVERNMENT IN THESE TREATIES IS A MISNOMER, BECAUSE IT IMPLIES SOVEREIGNTY OVER THE REAL GOVERNMENT AND THAT ACCORDING TO INTERNATIONAL LAW IS THE PEOPLE AT ALL TIMES, THE PARLIAMENT IS THE CORRECT TERM. WE THE EXECUTIVE ARE THE VOICE OF THE REAL GOVERNMENT THAT IS THE AUSTRALIAN PEOPLE. RESPECT FOR THE PEOPLE SHOULD BE OF A PRIORITY WHEN IT COMES TO TREATIES. WE THE EXECUTIVE ARE THE SERVANTS OF OUR MEMBERS. WE THE EXECUTIVE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT ON THIS TREATY.
