DEAR SIRs.



OF COURSE IF AUSTRALIANS AT THE LEVEL OF FEDERAL PARLIAMENT CHOOSE TO IGNORE TREATIES THEN ONE COULD EXPECT THAT ENFORCEMENT WILL NOT HAPPEN. THIS EXECUTIVE FULLY SUPPORT THE URGENT NEED FOR PROTECTION OF SPECIES OF ALL KINDS TO BE PROTECTED, HABITATS ARE DAILY BEING DESTROYED BY MANKIND IN THE NAME OF URBAN DEVELOPMENT AND GREED OF THE INTERNATIONAL BANKING GROUPS WHERE MINING OR RESEARCH TAKES PLACE.
