1. The long lasting use of expression "Sole Parent"

In 1998 I addressed Victorian Senators, and

several Ministers asking that the expression "Sole Parent" be

removed from all Federal legislation or other papers and speech. (Copy attached / appendix A)

As I suffered a health problem when initial acknowledgments

were advised, some details of actions may have been mislaid.

Despite some 3 years passing, the expression "Sole Parent"

continues though it was apparently no longer in written material in the Parliaments control.

It is with repugnance that I see that a organisation continues to call itself "Sole Parents Union", leaving aside and unapparent such points as

- (a) it was a virgin birth?
- (b) one parent has died?

Is this, apparently Females serving organisation, receiving any Commonwealth funding and if so how does it avoid a bias of Discrimination if a simply estranged parent still lives?

A presumption of shared custody will avoid this.

2. Future of child raising, and care of aged parents.

Re:- "SOLE PARENT"

Dear Senator XXXXX , and parliamentary colleagues.

I am reminded today of the expression "Sole Parent" to the denial of rights of millions of other parents in the community, by another round of publicity about domestic violence, and recent discussions about poverty, pensions and family life.

In the 1993 and 1996 general elections I sought caring representatives who would legislate to make impartial Social Security titles and encourage common usage, that recognises with dignity the previous partners (usually men) of "Sole Parents". *attached* 1 & 2

My further pursuit of this objective was referred in 1996 per Dr. Wooldridge to Social Security Ministry and an administrative reply received. *attached 3*.

The connection with "domestic" violence is the extreme isolation of children from the estranged parent in matrimonial breakdowns. It seems all too easy and a routine to allege fear of contact and use a restraining order as a basis for parental alienation. The current Government persists in labelling custodians as "Sole" parents and entrapped men as "Violent Perpetrators", without proof or sympathy of circumstances.

The expression "Sole Parent" could be removed from official use by suitable text in the May 1998 Budget statements and announcements in non gladiatorial terms, acknowledging parenthood as a continuing joint honour and privilege, as expected in Child Support and Family Court motives.

I pray that you and your houses will now act for reform to remove this entrenched discriminatory title. Please confirm *your* actions to writer.
