Appendix I — Conduct of the inquiry

The House of Representatives Standing Committee on Industry, Science and Technology commenced an inquiry into Australian industry participation in major projects during the 37th Parliament. The Committee decided to take a case study approach to the inquiry, commencing with the North West Shelf gas project. The terms of reference for that inquiry and membership of the Committee are listed at the beginning of the report.

At the dissolution of the House of Representatives in 1996, the Committee had not completed its inquiry.

After the commencement of the new Parliament, the Minister for Industry, Science and Tourism, the Hon John Moore, wrote to the Committee Chair, the Hon Bruce Reid, requesting the Committee to reactivate the inquiry with revised terms of reference. These terms of reference are listed at page iii.

Advertisement of the inquiries

The inquiry was advertised nationally in major metropolitan newspapers on Saturday, 17 June and Monday, 19 June 1995. The Committee wrote to relevant Federal Ministers and to State and Territory Governments. In addition, 90 potential stakeholders, including trade and industry associations, received invitations to make submissions to the inquiry.

After the inquiry was reactivated in 1996, those who had made submissions to the previous inquiry were invited to make further submissions.

Evidence to the inquiries

The Committee received 59 submissions, all of which were authorised for publication. These submissions are listed in appendix II.

The Committee received 52 exhibits to the inquiry, some of which were provided as attachments to written submissions. Except for one of the exhibits, which was accepted in confidence, the exhibits are listed in appendix III.

In 1995 and 1997, the Committee took evidence at public hearings in Perth, and inspected Woodside facilities at Karratha and the North Rankin A platform. The Committee also took evidence at public hearings in Canberra in 1997. The Committee called 42 witnesses to give evidence at public hearings and 277 pages of evidence were recorded by Hansard. Details of the hearings and witnesses appearing are in appendix IV.

The Committee was also briefed privately by the Secretary to the Department of Industry, Science and Tourism.

The transcripts of evidence taken at public hearings and copies of all written submissions will be made available for inspection at the Committee Office of the House of Representatives and at the National Library of Australia.
