Terms of reference

38th Parliament

The Committee is asked to investigate and report on:

- the level and nature of participation by Australian industry in the main types of major infrastructure projects;
- the net benefits to Australia of greater Australian industry participation in such projects;
- the capacity and capability of Australian-based companies to participate in major infrastructure projects domestically, regionally and globally;
- key access points for Australian participation in major infrastructure projects including impediments and constraints to exploiting domestic and overseas opportunities;
- policies and mechanisms that could be adopted by governments to enhance national benefits for participation in major infrastructure projects.

An inquiry into Australian industry participation in major projects was commenced in the 37th Parliament; however, when the House was dissolved the inquiry was unfinished. The terms of reference for that inquiry are set out on the next page.

37th Parliament

The Committee was requested to inquire into and report on Australian industry participation in major projects in Australia, including but not limited to:

- oil and gas developments;
- mining and minerals processing;
- metal smelting and refining; and
- major infrastructure projects.

The Minister suggested that the Committee examine several projects as case studies of Australian industry capacity and capability to participate in such major projects. These projects were to include both those that have achieved high Australian content such as recent naval shipbuilding projects, as well as those that have not. In particular, the Committee was requested to examine:

- the capacity and capability of Australian industry to participate in design and construction work associated with major projects;
- the actual level of Australian participation achieved in major projects by different industry areas including design, project management, and equipment supply;
- the potential for export earnings for Australian industry in similar projects overseas;
- the potential to achieve improved innovation, technology transfer and skills development in Australian industry through more effective links with major projects and firms associated with these projects;
- the broader economic impact for Australia of major projects;
- the policies currently adopted in Australia and other countries relating to the establishment and operation of major development projects; and
- the policies and mechanisms that should be adopted by government in Australia to enhance the level of Australian industry participation in major development projects and to maximise the benefits to the Australian people from such projects.

Foreword

The House of Representatives Standing Committee on Industry, Science and Technology commenced an inquiry into Australian industry participation in major projects during the 37th Parliament. The Committee decided to take a case study approach to the inquiry, commencing with the North West Shelf gas project, as a follow up to a 1989 report of the Standing Committee on this matter.

At the dissolution of the House of Representatives in 1996, the Committee had not completed its inquiry. After the commencement of the new Parliament, the Committee sought the re-referral of the terms of reference so that the case study on the North West Shelf could be completed. The Minister for Industry, Science and Tourism, the Hon John Moore, agreed to the Committee's request to reactivate the inquiry, but with revised terms of reference. The terms of reference for the two inquiries leading to the current report are listed at pages iv and v.

The North West Shelf gas project has been described as the biggest resource project ever undertaken in Australia, with an estimated investment of \$12 billion. The Committee found that significant factors affecting participation in the project by local industry included technological changes in petroleum extraction, the trend towards alliances and the way in which the Federal and State bureaucracies performed their roles and interacted with industry.

The Committee regrets that the Federal bureaucracies still do not appear to play a significant role in promoting and fostering local industry content in major projects. Indeed the Committee believes they are indifferent to the real opportunities for domestic industry growth which continue to be presented by the vast potential of fields to the north and west of Australia.

The Committee has proposed changes to ensure industry practices and government policies assist Australia to benefit to the greatest extent possible in the supply of goods and services to the industries participating in the development of this natural resource.

I wish to thank all those who gave their time and effort to contribute to the inquiry. Woodside Offshore Petroleum Pty Ltd very kindly allowed the Committee access to its facilities, and this greatly assisted members of the Committee in their inquiries.
