House Economics Committee looking into credit card, debit card and ATM fees

The House of Representatives Economics Committee will hold public hearings with the Reserve Bank of Australia and other interest groups for an inquiry into the payments system. These hearings follow on from the hearing held with the Reserve Bank Governor on 17 February 2006.

The hearings will be on Monday 15 and Tuesday 16 May 2006 in Committee Room 814/815, NSW Parliament House, Sydney.

The committee, chaired by Bruce Baird (Member for Cook, NSW), will examine the payments system with particular reference to the Reserve Bank's recent and proposed reforms. Specifically, the committee will be looking at fees and charges for credit cards, debit cards and ATMs. It will also seek the views of Australian Bankers' Association, Australian Consumers Association, economists Ric Simes and Joshua Gans, Mastercard, Visa and American Express.

"The committee has a mandate to watch over the Reserve Bank, and the payments system is an important area of the Reserve Bank's responsibilities," Mr Baird said.

"The payments system is an area that affects almost all Australians and, given the lively public debate between various groups over the past few years, the committee felt it was time to weigh in and have a thorough look at the issues."

"These hearings provide an important forum for the parliament to discuss the key issues with the Reserve Bank, the major interest groups and two academics who specialise in the area. Over past few years the RBA has embarked on some fairly significant reforms - some groups like them, others don't. It is important that the parliament is kept informed about these issues."
