- Meeting future and changing health service needs Big changes are occurring in Australia's demographics in parallel with changes in medical services and delivery, medical education and health consumer aspirations. A NBN provides the best means of meeting these challenges by providing high quality, accessible and affordable infrastructure to receive and deliver all aspects of a good quality health system.
- 2. High quality and reliable NBN service that allows high speed transmission - For health services to be efficient and accessible, and for the country to realise the benefits of the growing suit of ehealth technologies and services, Australia needs a high quality, rapid transmission infrastructure like the proposed NBN that will be accessible to as many people as possible at an affordable rate.
