DEAR SIRs.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS PROTOCOL BE RATIFIED , WE AGREE THAT PROTECTIONS BE IN PLACE CONCERNING PERSONS WITH MENTAL ILLNESS, HANDICAPPED PERSONS WHO ARE AT THE MERCY OF SOCIETY. OUR ONLY CONCERN IS HOW THOSE WHO SUFFER INJUSTICE WOULD KNOW THAT THEY HAVE RIGHTS, OR HOW TO BRING FORWARD A CLAIM. PEOPLE WHO HAVE DISABILITIES FEEL HELPLESS WHEN THEY ARE A VICTIMS TO A VIOLATION . IF A PERSON MAKES A COMPLAINT OF A VIOLATION , AFTER IT IS DEALT WITH AT DOMESTIC LEVEL , THEY WOULD NOT UNDERSTAND HOW TO TAKE THE MATTER FURTHER . THE EXECUTIVE DO NOT KNOW THE CORRECT PROCEDURES TO TAKE. HOWEVER THE EXECUTIVE FULLY SUPPORT THE PROTOCOL , WE THANK THE RUDD PARLIAMENT FOR THE RECENT ONE OFF PAYMENT, TO PEOPLE WITH DISABILITIES , BUT WE BELIEVE THAT THE MULTINATIONALS SHOULD PAY A TAX TO PROVIDE PENSIONERS , AND PERSONS WITH A DISABILITY CHEAPER HOUSING , TRANSPORT , MEDICINES . THE RICHEST NATION ON EARTH SHOULD NOT HAVE HOMELESS PEOPLE , POVERTY , CITIZENS WITH MENTAL ILLNESS UNABLE TO BE HOUSED, IN SPECIAL CARE . FOREIGN AID PAYMENTS SHOULD CEASE UNTIL ALL AUSTRALIANS ARE PROVIDED FOR , CHARITY BEGINS AT HOME . COMPANY TAX SHOULD BE INCREASED FOR THOSE COMPANIES EARNING OVER A BILLION DOLLARS PROFIT EACH YEAR . A NATIONAL FUND COULD BE SET UP USING A ONE PER CENT DEBIT TAX ON ALL FINANCIAL TRANS
